Food & non-food contact surfaces At time of the inspection, the door gasket for refrigerator PC# 653902 is broken; and there is leak under two compartment sinks located in front the office manager. Replace damaged door gasket. Work order done. Repair leak under two compartment sinks.</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
